# Uninsured American Indians and Alaska Natives with Incomes 133% to 300% of Poverty: Data for Health Insurance Exchange Outreach

---

## Summary

A primary goal of the Affordable Care Act of 2010 is to see that low and moderate income uninsured people have affordable health insurance options available. It is the purpose of this report to provide the Center for Medicare and Medicaid Services (CMS) Tribal Affairs Group and its advisory CMS Tribal Technical Advisory Group (TTAG) with data on the American Indians and Alaska Natives (AIAN) with household incomes between 133% and 300% of the federal poverty level who have no health insurance and could benefit from targeted outreach activities to inform them of their options.

The estimated numbers of uninsured AIAN in the Indian Health Service (IHS) Areas with household incomes between 133% and 300% of the federal poverty level are presented in this report. Basic age and gender demographic data are presented for both the uninsured AIAN who obtain some or all of their health care in the IHS system and those who do not. The numbers and demographics for each of the 12 IHS Areas are presented in the form of 12 sets of fact sheets. In this way the relevant data for people in each Area planning and conducting outreach to the uninsured is available in just 2-3 pages.

The source of the data on health care coverage is the annual American Community Survey (ACS) of the U.S. Census Bureau. At least 3 years of the ACS survey data are needed for a reliable sample of most county populations in the U.S. Three years of the ACS survey data on health insurance coverage will not become available for analysis until November 2011. At the time of the analysis for this report, data for only a single year was available (2008), the first year the health insurance question was added to the ACS survey. Therefore reliable IHS Area data was obtained for Aberdeen, Alaska, Billings, California, Nashville, Oklahoma and Portland Areas by using state level data for the IHS Areas. For Albuquerque, Navajo, Phoenix and Tucson Areas sufficient numbers of AIAN were available within most IHS Contract Health Service Delivery Area (CHSDA) counties of the Areas to allow use of county level data for the IHS Areas. After November 2011 there will be sufficient ACS data so that all 12 IHS Areas can be estimated with county level data. ACS data from 2008 was adequate in numbers to estimate counties served by Urban Indian Health Programs, and those counties are reported in the IHS Areas in which they are located.

Because survey data is based on a sample of the population, the numbers in the report are not the same as those that would be obtained if everyone in the population were actually counted. The numbers of AIAN in every group in the fact sheets are derived from estimates generated by the U.S. Census Bureau with statistical projections that have calculable margins of error. The smaller the number of AIAN in a survey sampling area the less reliable is the number of AIAN reported. We do not provide upper and lower statistical limits for the estimated numbers of AIAN in this report because of the short time (2 months) allotted for generating this study. We have minimized the error by using state level data where IHS Areas include multiple states, and using county level data for IHS Areas only where more than one Area serves more than one county within a state. In future studies of ACS health care coverage data using county level methods only, the upper and lower limits for the ACS estimates can be calculated and included in the report.

## Introduction

Health Care Reform legislation of 2010 (the Affordable Care Act or ACA) included provisions to make health care insurance less costly for families with low and moderate incomes that otherwise could not afford it. Expansions of Medicaid were included for people with incomes up to 133% of the federal poverty level. Tax credits that reduce health care insurance premium costs were included for people with incomes under 400% of poverty.

It is the intention of the CMS Tribal Affairs Group of the Office of External Affairs and Beneficiary Services (OEABS) to see that there are targeted outreach activities to uninsured American Indians and Alaska Natives (AIAN) within the income range of 133% to 300% of poverty to promote access to state Health Insurance Exchanges and other expanded health care coverage resources that will become available as ACA is implemented. To help plan those targeted outreach activities the CMS Tribal Affairs Group contracted with the California Rural Indian Health Board (CRIHB) to provide data on the uninsured population of AIAN that falls within the income range of 133% to 300% of poverty and to identify geographic areas for the targeted outreach activities.

According to the American Community Survey of the US Census Bureau, there are about 472,000 AIAN without health insurance living in households with incomes between 133% and 300% of poverty. Nine-tenths (90%) of those AIAN lived in the 35 states of the Indian Health Service (IHS) healthcare delivery system. Over a third (38%) of those uninsured AIAN declared they had IHS coverage – which is to say they had access to IHS healthcare providers although they had no health insurance. But a much larger proportion (62%) of the uninsured AIAN in those states did not have access to IHS healthcare, and they are included in this report as well.

It is the purpose of this report to provide the CMS Tribal Affairs Group and its advisory CMS TTAG with a demographic analysis of gender and age groups of the uninsured AIAN populations living in households with incomes between 133% and 300% of poverty. The data is provided separately for the uninsured AIAN in the IHS healthcare delivery system, and other uninsured AIAN not in the system so that targeted outreach activities can be focused on both groups in the IHS Areas.

## Methods

**Data Source.** We analyzed data from the 2008 American Community Survey (ACS) which was the latest data available. The data is available for public use via the online 'Data Ferret' data query system of the U.S. Census Bureau (<http://dataferrett.census.gov/support/user/index.html>). The 2008 survey data was made available online at the end of November 2009. The 2009 survey data had not been made available when we performed the analyses for this report (August to October 2010). No data earlier than 2008 was available from the ACS on health insurance coverage.

The ACS is a nationwide survey by the U.S. Census Bureau designed to provide communities data on how they are changing from year to year. The ACS collects population and housing information such as age, race, income, commute time to work, home value and veteran status. Collecting data every year provides more up-to-date information throughout the decade about the U.S. population at the local community level. During development of the survey in the late 1990's and early part of this century the ACS undertook meetings, presentations, and other activities to support the ACS in areas where AIAN live. These activities included meetings with tribal officials and liaisons and attendance at the National Conference of American Indians (NCAI). To this day there are continued

interactions with the ACS Advisory Committee for the AIAN populations. For more on ACS survey methods with AIAN see “A Compass for Understanding and Using American Community Survey Data: What Users of Data for American Indians and Alaska Natives Need to Know.”

In the ACS survey about three million housing unit addresses are sampled annually, including every county in the nation. The ACS then produces 1-year estimates of the responses annually for geographic areas with a population of 65,000 or more. This includes all states, approximately 800 counties, and 500 metropolitan and micropolitan statistical areas. It takes 5 years of combined survey data to produce estimates for every county in the nation. For low population rural communities it can take 5 years to accumulate a sufficient number of responses to accurately represent the community. For more on ACS survey methods see the “Design and Methodology Report” that contains descriptions of the basic design of the ACS and details of the full set of methods and procedures ([www.census.gov/acs/www/methodology/methodology\\_main](http://www.census.gov/acs/www/methodology/methodology_main)).

**American Indians and Alaska Natives (AIAN).** We analyzed data for people whose racial heritage included American Indian or Alaska Native, regardless of any other race or any Hispanic ethnicity that was also reported. People who answered the survey declared the racial heritage of themselves and their household family members.

**133% to 300% of Poverty.** We analyzed the subgroup of AIAN who lived in households with incomes between 133% and 300% of the Federal Poverty Level (FPL, or ‘poverty’). The ACS converts the incomes people report for their household family members to a percentage of poverty for a household with that many adults and children. They report the income in terms of a continuous index from 0 to 500%. We were instructed to use the range of 133% and

300% of poverty because people in that group would be eligible for subsidized premiums and no cost sharing in state Health Insurance Exchanges. We were furthermore asked to focus on the 35 states of the IHS healthcare delivery system (all 50 states are presented by state in Appendix A). People with lower incomes (less than 133% of poverty – or actually up to 138% of poverty with income set asides) are also eligible for subsidized premiums and no cost sharing, and the numbers and demographics of uninsured AIAN in this income group are presented by state in Appendix B of this report. People with incomes between 301% and 400% of poverty are also eligible for subsidized premiums and the numbers and demographics of uninsured AIAN in this income group are presented by state for all 50 states in Appendix C of this report.

**Uninsured.** We analyzed data for two separate groups of Uninsured AIAN: those with IHS coverage (‘IHS System’), and the rest of the uninsured (‘Other Uninsured’). Only in 2008 did the ACS begin asking households about their health care coverage. The survey asked about 8 separate types of health insurance and health coverage plans. Respondents are considered to be “Uninsured” if they answered “No” to all 6 types of insurance and coverage: a)

Insurance through an employer or union; b) Insurance purchased from an insurance company; c) Medicare; d) Medicaid; e) Tricare (Military); f) Veteran's Administration, and they filled in no other type of health insurance or health coverage plan in the last line of the question. However, if a respondent indicated 'Yes' they had Indian Health Service coverage (response 'g'), and that is the only 'Yes' they indicated, they were still classified as Uninsured. In other words, Indian Health Service (IHS) coverage was not considered as health insurance or comprehensive health care coverage.

## Representing IHS Areas with One Year of ACS Survey Data

ACS survey data collected in one year is representative of geographic areas with a population of 65,000 or more. This includes all states, but only about 800 of the more than 3000 counties in the US. This means that while ACS survey data can provide statistical estimates of preselected county areas in any given year (a Public Use Microdata Area, PUMA), the county estimates provided from those PUMA with one year of ACS survey data are not statistically reliable for most counties in the US. Combining multiple years of ACS health insurance data will be possible in years to come and is described at the end of this section.

Without county level health insurance coverage data at this time we were unable to use the usual method of representing IHS Areas by aggregating county data as we have in previous reports of CMS Medicaid and Medicare data. The service areas of the 12 IHS Areas can be approximated geographically by Contract Health Service Delivery Area counties (CHSDA counties were last defined in the document: "Indian Health Service Geographic Composition of the Contract Health Service Delivery Areas and Service Delivery Areas of the Indian Health Service," Federal Register/Vol. 72, No. 119/Thursday, June 21, 2007/Notices [www.ihs.gov/NonMedicalPrograms/chs/documents/CHSDA\\_FEDERAL\\_REGISTER\\_NOTICE\\_June\\_21,2007.doc](http://www.ihs.gov/NonMedicalPrograms/chs/documents/CHSDA_FEDERAL_REGISTER_NOTICE_June_21,2007.doc)).

Instead we had to use two separate methods: state level estimates for IHS Areas that dominate the states in which they have CHSDA counties: Aberdeen, Alaska, Billings, California, Nashville and Portland; and county level estimates for IHS Areas that have CHSDA counties of more than two IHS Areas within the state borders: Albuquerque, Navajo, Phoenix and Tucson. While IHS Areas are better approximated by counties, one year of county level survey data for counties with small populations is not as reliable an approximation as state level survey data. After 2011, with 3 years of survey data the County Level Estimate technique can be used for all IHS Areas.

- **State Level Estimates.** In states with CHSDA counties of only one IHS Area (or no more than one CHSDA county of a second IHS Area): we used state data counts of "Uninsured AIAN with IHS Coverage" as best estimates of the numbers of AIAN for that IHS Area, and used the counts of the rest of the Uninsured AIAN in the state as best estimates of "Other Uninsured AIAN"-both in the IHS Area counties and the rest of the state counties combined. Further documenting the Urban county data for counties served by an IHS system Urban facility allowed further resolution of Uninsured AIAN outside of CHSDA counties (which are primarily non-urban). If only one CHSDA county of an IHS Area existed in a state that state was not included in the estimates for the IHS Area in question: for example, because there is only one CHSDA county of the Aberdeen Area in Minnesota, Minnesota state is not included in the Aberdeen Area. For the same reason Utah is not included in the Portland Area; Nebraska is not included in the Oklahoma Area; Texas is not included in Oklahoma Area, etc. Maps of the CHSDA counties are shown for each Area, and excluded states and counties are shown in the map of the Area.
- **County Level Estimates.** In states with more than one CHSDA county of more than one IHS Area, we calculated statistical estimates using the county estimates based on American Community Survey sampling

areas (Public Use Microdata Area- 5% sample, PUMA5) for CHSDA Counties. Where more than one county was included in a PUMA5 area, the value for the PUMA5 area was multiplied by the fraction of the population in the CHSDA County of the PUMA5. This fraction termed the 'A5' allocation factor is provided by the American Community Survey based on Census 2000 populations on which the survey sample is based. Where a PUMA5 area is the same as one CHSDA county, or where more than one PUMA5 area was included in a CHSDA county (populous counties of 130,000 or more people), the 'A5' allocation factor of the estimate of Uninsured people for the county to the CHSDA County is 1. This is a standard way of making a synthetic estimate of a number of people in a group with only aggregate data. These synthetic estimates can be improved when counts from 3 years of ACS insurance data become available in 2011, and are unnecessary with survey data from 5 years of ACS data in 2013.


- **CHSDA Split County estimates** were needed for 10 CHSDA counties in 4 IHS Areas (Albuquerque, Navajo, Phoenix, and Tucson). In these cases the most recent IHS county split for the Service Units of each Area was obtained. The IHS Area share for each county was allocated to the proper Area by also multiplying times the fraction of the population in the CHSDA County of the PUMA5 times the fraction of the IHS Service Population of AIAN allocated to each IHS Area in each split county. Since 98% of the AIAN population of the 2 split counties of the state of California were allocated to the California Area, no attempt was made to estimate the small 2% to allocate to Phoenix Area.
- **Urban County estimates.** In every IHS Area except Alaska Area, there is one or more designated Urban Indian Health Organizations that owns or operates an IHS funded Urban Indian Health Program. There are 34 in all throughout the 35 states of the IHS healthcare system, and one in Chicago, Illinois. According to the programs themselves, they serve AIAN living in 98 counties (Urban American Indian/Alaska Native Maternal, Infant and Child Health Capacity Needs Assessment, Appendix C. *Urban Indian Health Institute*, January 2008. [www.UIHI.org](http://www.UIHI.org)). Using the same methods as for CHSDA counties, we calculated statistical estimates for these 98 'urban' counties using the PUMA5 county estimates, and if appropriate the IHS split county fractions. If a CHSDA County was also included in the Urban Counties, the AIAN were counted only once in the total count for the Area.

**Limitations of the county level estimates.** We have developed methods to use publically available online ACS PUMA5 survey data estimates to estimate populations in IHS Area states and counties. All ACS estimates are based on survey samples that include a range of uncertainty associated with them, and this range of uncertainty is described by a standard error. Standard errors are important to consider when using data from the ACS, or any other survey. The standard error can be converted to a margin of error for a set confidence level, such as 90% confidence. The margin of error gives an upper and lower limit on the likely values of each number for that level of statistical confidence. Online ACS data sets and tables contain 'replicate weights' for each estimate that can be converted to standard errors with statistical software. In the future more time will be allotted to projects that use the ACS for AIAN in order to provide the upper and lower limits of the margin of error for each number provided in the fact sheets.

ACS county level survey estimates for small populations like AIAN are not highly reliable without survey results from multiple years. Insurance coverage data for three ACS survey years (2008-2010) will be available in November of 2011. From 2012 on three years of ACS data can be combined to represent geographic areas with a population of 20,000 or more, including all states, and approximately 1,800 counties. For the rest of the counties, the standard errors of the estimates can be reported with the estimates.

A third limitation of the numbers reported is that public use online data uses smaller ACS samples than the data that is available through the ACS. This is to make it extremely remote that anyone could identify an individual's survey response record in the data even if they knew a person who responded to the survey in a small population area in a given year. The U.S. Census Bureau grants access to the full ACS data sample only for approved projects after thorough background checks of the people to whom the data is released. Such enriched ACS data for approved AIAN projects at CMS is potentially available in the near future through the office of the Assistant Secretary for Planning and Evaluation.

**Urban Counties:** Of the 22,797 uninsured AIAN in the 4 states, 866 (4%) are in the urban counties served by IHS funded Urban Indian Health Programs; 80% of those urban uninsured AIAN are in the IHS system and 20% are not.

**South Dakota:** 12,093 AIAN

**Urban counties in South Dakota:** Of the 12,093 uninsured AIAN in South Dakota, 620 (5%) are in the counties served by IHS funded Urban Indian Health Programs (Brown, Hughes and Minnehaha counties). Nearly three-fourths (71%) of these urban uninsured AIAN surveyed indicate that they have IHS coverage, the rest did not.








**Percent of Uninsured AIAN in the the IHS System in Major Age Groups**




**PROFILE OF THE UNINSURED WITH INCOMES 133% TO 300% OF POVERTY



**CHSDA Counties:** The service delivery area counties of the IHS and Tribal healthcare system in the Albuquerque Area are in 4 states, but in Utah only one county is included. That county (San Juan County) is actually split between the Albuquerque and Navajo Areas and essentially the entire service population (99.9%) is assigned to Navajo Area. As a result the number of uninsured AIAN in the Utah split county assigned to Albuquerque Area is too small to be estimated. Therefore Utah is not included in the Albuquerque Area data. Utah county data is provided for Navajo and Phoenix Areas.


**Albuquerque CHSDA counties split with Navajo Area:** The county estimates of uninsured AIAN were split with the Navajo Area in 4 counties of the state of New Mexico using the IHS fraction of the service population of AIAN assigned to each of the two Areas in each of the counties.

**Urban Counties:** Of the 19,444 uninsured AIAN in the counties of the 3 states, 8,846 (45%) are in the urban counties served by IHS funded Urban Indian Health Programs, 24% of those urban uninsured AIAN are in the IHS system and 76% are not. One of the urban counties (Bernalillo in New Mexico) is also a CHSDA county. We included the uninsured AIAN in that county (2,750 AIAN) only once in the number totals.

**New Mexico Counties:** 12,279 AIAN

**CHSDA Counties in New Mexico:** There are 9 whole and 4 split counties in the service delivery area of the IHS healthcare system in the Albuquerque Area. The 4 counties are split between the Albuquerque and Navajo Areas (for Cibola, McKinley, Rio Arriba, and Sandoval Counties in New

Mexico). The IHS establishes the proportions of the service population in split counties that are assigned to the two Areas. These fractions were used to allocate the uninsured AIAN population to the Albuquerque Area.

**Urban County of New Mexico:** Of the 8,451 uninsured AIAN in the IHS Albuquerque Area counties of New Mexico 2,750 (22%) are in a county served by an IHS funded Urban Indian Health Program (Bernalillo County) which is also a CHSDA county with at least non-urban IHS system Service Unit. In that county 48% of the uninsured AIAN are in the IHS system and 52% are not.

**Colorado Counties:** 6,705 AIAN

- In the IHS System: 902 AIAN
- Not in the system: 5,803 AIAN




**Percent of Uninsured AIAN in the IHS System in Major Age Groups**



**Percent of Other Uninsured AIAN Not in the IHS System in Major Age Groups**








**Percent of Uninsured in the IHS System in the Age Groups**



**Percent of the Other Uninsured in the Age Groups**




**Percent of Male and Female Uninsured**



**Number and Percent of Uninsured AIAN with and without IHS Coverage**
















