Change to Occur to Medicare Cards-- Elders, Enrollment Assisters, beware of potential scams!

By April 2019, the Centers for Medicare and Medicaid services is required to remove Social Security Numbers (SSNs) from all Medicare cards.


A new Medicare Beneficiary Identifier (MBI) will replace the SSN-based Health Insurance Claim Number (HICN) on the Medicare cards for Medicare transactions.

This change is designed to fight medical identity theft for people with Medicare. CMS will begin mailing out new Medicare cards starting April 2018 in anticipation of this change.

Consumers, Patient Benefits Counselors, and Health Educators, be aware of this change and the potential for scams and fraud targeting our Native Elders. Learn about the possible changes and details to ensure that your community members do not fall victim to health scams or fraud.

Remember, scammers and frauds rely on confusion and misinformation with their targets. Some scammers may attempt to contact consumers and claim to be representatives of Medicare and collect personal information or payment.

#### **Medicare Equitable Relief Assistance Available Now!**

Medicare Equitable Relief Assistance Available Now! The Centers for Medicare and Medicaid (CMS) offers equitable relief to certain individuals enrolled in both Medicare Part A and coverage through the marketplace, for individuals and families to enroll in Medicare Part B without penalty!

CMS is also offering equitable relief to certain individuals who dropped or lost their coverage through the Marketplace and are paying a late enrollment penalty form the subsequent late enrollment into Medicare Part B.

Equitable relief is limited to individuals who are currently are or were enrolled in coverage through the Marketplace for individuals and families and are entitled to Medicare premiumfree Part A. In addition, to be eligible for the equitable relief, the induvial must have:

- Have an Initial Enrollment Period (IEP) that began April 1, 2013 or later; or
- Have been notified of a retroactive premium-free Medicaid Part A award on October 1, 2013 or later.

Through this program Individuals may have their penalty reduced.

Individuals can apply for Medicare Part B enrollment opportunity and reduction in late enrollment penalties during a limited time. It is available now and ends September 30, 2017!

To see if you qualify or claim equitable relief individuals should contact Social Security at 1-800-772-1213 (TTY users should call 1-800-325-0778) or visit their local Social Security office for more questions. Individuals can also mention they are interested in applying for "equitable relief" when submitting their Medicare part B enrollment documents.

## Marketplace Learning Management System (MLMS) Offline For New Training, Updates coming for 2018

Some of you may be familiar with the Marketplace Learning Management System (MLMS) used to educate Navigators and Certified Application Counselors (CACs) on health care reform and interacting with consumers. The MLMS system is a vital resource for health educators to understand and interact with CMS programs.

Updated yearly, the MLMS houses a training for Navigators and Certified Application Counselors on the changes in the health insurance Marketplace. Currently, the training for 2017 has closed from the previous year and CMS Is in the process of uploading the 2018 training content. Stay tuned for the release of this material so that you may begin your training for the 2018 year!

Some of the changes to the MLMS system for calendar year will include:

- Updates to the "Find Local Help" tool that allow the user to display contact information for all states in which they are licensed.
- Improvements to how the curriculum is displayed to make it easier for you to find the appropriate courses
- Ability to customize the MLMS profile fields by selecting an appropriate role
