# THE ORIGINAL GOAL OF THE CMS/IHS DATA MATCH

To identify the number of **American** Indians/Alaska Natives enrolled in Medicaid

### **BACKGROUND**

#### DATA USED

IHS 2019 user population - anyone who utilized IHS/Tribal/Urban (I/T/U) services at least once during October 2016- September 2019

2019 T-MSIS Medicaid data

#### DATA MATCH

Variables used: (last four digits SS #, birth date, gender, state, some characters of name)

Health Apt performed the data match

### **ACCESS TO DATA**

The data was deposited in the Virtual Resource Data Center (VRDC) with four variables: State, Bene\_ID, IHS flag (only equal to 1), and IHS identifier

### WHAT WE KNOW

In 2019, the number of IHS users who were enrolled in Medicaid is equal to:

824,605








# COMPARISON OF MEDICAID ENROLLMENT RATES (%)

- (2)How does the 2019 IHS User Population Medicaid Enrollment Data compare to the ACS data of Medicaid Enrollment among those who have access to IHS?




(1)Comparison to the ACS Medicaid enrollment data:


(2) Comparison to the ACS "Access to IHS" Medicaid enrollment data:


