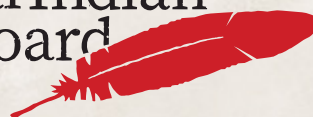

INTRODUCTION

This report provides estimates of American Indian/Alaska Native (AI/AN) enrollment in Medicaid, Medicare, and Uninsured for the United States (US), all 50 states, and the District of Columbia (DC), the latter of which is hereafter referred to as a state for the purposes of this report.

The first page for each state provides a table of AI/AN enrollment in Medicaid, Medicare, and Uninsured for 2013 and 2023. The table shows both the change and the percentage change in insurance enrollment from 2013 to 2023.

The middle graph on the first page for each state depicts enrollment rates for Medicare, Medicaid, and Uninsured from 2013 to 2023 for both AI/ANs and the Overall population. These enrollment rates were calculated by dividing the number enrolled in each insurance type by the total population, for both AI/ANs and the Overall population in 2013 and 2023.

At the bottom of page one for each state are charts showing dual enrollment rates for AI/ANs and the Overall population ages 65 and greater. These charts show the percentage of those ages 65 and greater enrolled in Medicare only, both Medicare and Medicaid, and neither Medicare nor Medicaid in 2023.

The second page for each state focuses on 2023 data, beginning with a chart showing Medicaid enrollment rates by age (0-18, 19-64, and 65 and greater) for AI/ANs and the Overall population. The next chart provides 2023 Uninsured rates by age group (0-18, 19-64, and 65 and greater) for AI/ANs and the Overall population. Finally, the last section provides highlighted comparisons for each state.

Data Description: American Community Survey Data

This report utilizes the American Community Survey (ACS) 5-year estimates for 2013 and 2023.¹ The 5-year estimate represents data collected over a period of the preceding five years. For example, the 2023 ACS 5-year estimate data includes survey data from 2019-2023 while the 2013 ACS 5-year estimate data includes survey data from 2009-2013. The 5-year estimates have increased statistical reliability for small population subgroups compared to the one-year data.² This is the eighth year the National Indian Health Board (NIHB) has produced reports on American Indian/Alaska Native health insurance enrollment. This year's report continues the comparison of current year estimates of Medicaid enrollment, Medicare enrollment, and Uninsured to estimates to 2013, which was the implementation year of the Affordable Care Act.

Population Definition, Sampling Error, and Omitted Variables

Data are based on a sample and are subject to sampling variability. The data in this report are reported without the margins of error. Every estimate has a sampling error. The American Indian/Alaska Native population is reported as respondents who self-report as American Indian or Alaska Native alone or in combination with one or more races. Foreign born are included in the AI/AN population estimates within this report.

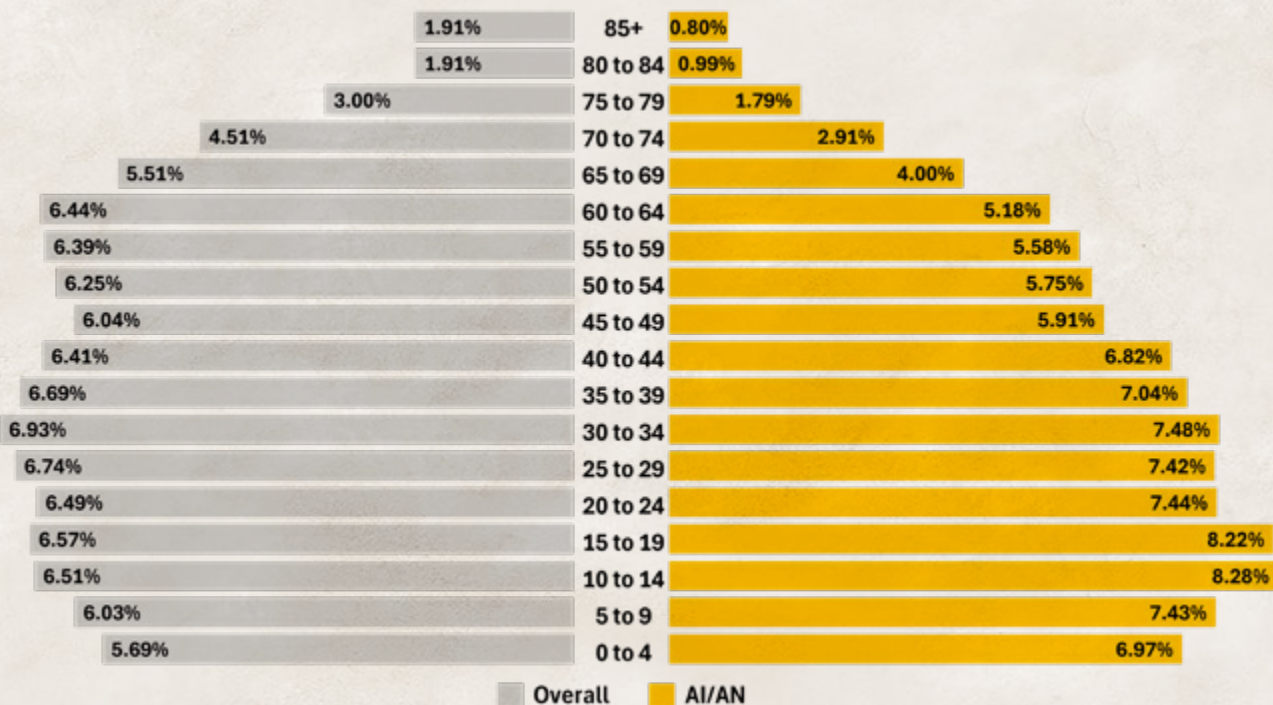
Note on Age Adjustment

In this report, NIHB does not adjust for differences in the age distributions of the populations being compared (AI/AN and Overall population). There are known differences in the age distributions of these populations. The life expectancy for an AI/AN person born in 2022 is 67.9 years compared to 77.5 years for the Overall population.

AI/AN life expectancies are lower than every other racial and ethnic group, ranging from 4.9 to 16.6 years lower.³ Because of this drastic inequity in life expectancy, the AI/AN population skews younger in age distribution than the Overall population.

The figure below uses ACS 2023 data to illustrate the differences in the age distribution of the

Overall population compared to the AI/AN population. The figure depicts the impact of a lower life expectancy for AI/ANs. Beginning with the age group “Between 45 and 49”, the percentage of the AI/AN population represented in that age group is smaller than the percentage of the Overall population represented in that same age group. This pattern continues for every group increasing in age. For example, 1.91 percent of the Overall population is “85 years and older” and only .80 percent of the AI/AN population is “85 years and older”. The percentage of the overall population who is 85 and older is more than double that of the AI/AN population.

AI/AN and Overall Population by Age for the US in 2023

The differences in age distribution have consequences relevant to this report. For example, these differences may affect Medicare enrollment rates, as most people do not become eligible for Medicare until age 65. In 2022, the life expectancy of the average AI/AN male was 64.6 years⁴ indicating that the average AI/AN male would not live long enough to become eligible for Medicare. Age-adjusting the Medicare enrollment rates would obscure the underlying inequity in life expectancy. Thus, NIHB intentionally does not age-adjust in this report to highlight these urgent inequities that must be addressed.

Concerns over Medicaid Undercount in ACS 2023

The 2023 Medicaid enrollment rates and enrollment numbers should be interpreted with caution. It has been well documented that the ACS data often undercounts Medicaid enrollment, with pre-pandemic estimates of undercounting ranging from 6.8 to 8.5 percent. However, starting in 2020, the undercount was estimated to be larger, at approximately 12.1%. For 2021, it was estimated that the undercount was approximately 15.1% when compared to CMS enrollment data.⁵ Another study estimated that there was “a 3.9 percentage point increase in the ACS’s “undercount” of

Medicaid enrollment, compared with CMS data, from 2019 to 2022”.⁶ Since this report utilizes 2023 ACS 5-year estimate data, it is difficult to determine the size of the Medicaid enrollment undercount. It has been hypothesized that much of the ACS undercount in 2020 and 2021 may be due to respondent lack of awareness around the Medicaid continuous coverage requirement. Continuous Medicaid eligibility means that very few enrollees were removed from Medicaid during the Public Health Emergency, but many may not have realized they still had Medicaid coverage since states were not required to notify enrollees of their continued coverage.⁷ The missing values for race in the Medicaid administrative data (Transformed Medicaid Statistical Information System – T-MSIS)⁸ make it difficult to determine the extent of the undercount of ACS data for AI/ANs. Thus, NIHB had not made any corrections to the ACS data. However, NIHB will continue to monitor this issue in the future and attempt to address concerns.

OVERALL TRENDS

This section discusses the overall trends found across all 52 regions (US, 50 states, and DC) in the report. While not evident in every state, these trends are true for the US as well as for most states. Comparison of your specific state to the US will help identify if your state follows the trends highlighted below.

Note that differences of less than one percent are considered the same for the purposes of this report.

AI/AN Enrollment in Medicaid, Medicare, and Uninsured in 2013 and 2023

In the US and all but four states, the AI/AN Medicaid enrollment increased from 2013 to 2023.¹ AI/AN Medicare enrollment increased from 2013 to 2023 for the US and all but one state.² Finally, the number of Uninsured AI/ANs fell from 2013 to 2023 in the US and 39 states.³

Please note that an increase or decrease in the number of AI/ANs enrolled in an insurance type does not necessarily imply that the percentage of AI/ANs enrolled in that insurance type, defined as the enrollment rate, changed in the same way. The first table in the report does not consider changes in the underlying AI/AN population from 2013 to 2023. While insurance enrollment numbers are helpful in some cases, readers are encouraged to use the graph of enrollment rates from 2013 to 2023 to identify patterns of enrollment in Medicaid, Medicare, and Uninsured in their state.

AI/AN Enrollment and Overall Population Enrollment Rates in Medicaid, Medicare, and Uninsured from 2013 to 2023

Medicaid

For the US and every state, the AI/AN Medicaid enrollment rate was larger than the Overall population Medicaid enrollment rate in 2013 and 2023. For the US and most states, the Medicaid enrollment rate for both AI/ANs and the Overall population increased from 2013 to 2023. However, there are two states where the Medicaid enrollment rate decreased for the Overall population from 2013 to

2023.⁴ In 11 states, the AI/AN Medicaid enrollment rate decreased from 2013 to 2023.⁵

Medicare

In the US and all but six states, the Medicare enrollment rate in the Overall population was larger than the AI/AN Medicare enrollment rate in 2013 and 2023.⁶ For the US and most states, the Medicare enrollment rate for both AI/ANs and the Overall population increased from 2013 to 2023. In all but one state⁷, the Medicare enrollment rate increased in the Overall population from 2013 to 2023. In seven states, the AI/AN Medicare enrollment rate decreased from 2013 to 2023.⁸

Uninsured

As mentioned previously, there were twelve states where the number of Uninsured AI/ANs fell from 2013 to 2023. However, when changes in the AI/AN population are considered, the Uninsured rates for both AI/ANs and the Overall population decreased for the US and almost every state, with only one exception.⁹ In addition, with only two exceptions, the AI/AN Uninsured rate was higher than the Overall population Uninsured rate for both 2013 and 2023.¹⁰

2023 AI/AN and Overall Population Dual Enrollment Rates in Medicaid and Medicare, for those Ages 65 and Greater

The last chart on each state's first page compares the Medicare and Medicaid dual enrollment rates for AI/ANs and the Overall population in 2023. For the US and every state except DC, the percentage of those age 65 and greater who are dually enrolled in both Medicare and Medicaid is higher for AI/ANs than for the Overall population. The proportion of those age 65 and greater who are enrolled in neither Medicare nor Medicaid is higher for AI/ANs than the Overall population in 30 states.¹¹

2023 AI/AN and Overall Population Medicaid Enrollment Rates by Age

The largest 2023 Medicaid enrollment rates for both AI/ANs and the Overall population is in the 0-18 age group for the US and every state. In addition, the AI/AN Medicaid enrollment rate is larger than the Overall population Medicaid enrollment rate for all age groups (0-18, 19-64, 65 and greater, and all ages) all but four states.¹²

2023 AI/AN and Overall Population Uninsured Rates by Age

The largest 2023 Uninsured rates for both AI/AN and the Overall population is in the 19-64 age group for the US and every state. In addition, for the 19-64 age group, the AI/AN Uninsured rate is larger than the Overall population Uninsured rate for the US and every state except Hawaii, where they are the same. For ages 0-18, the AI/AN Uninsured rate is greater than the Overall population Uninsured rate in 29 states.¹³ Lastly, for the 65 and greater age group, the AI/AN Uninsured rate is the same as the Overall population Uninsured rate in 34 states.¹⁴ This finding is a departure from the trend observed in the 2024 State Health Insurance Status Report, in which the AI/AN Uninsured rate for those 65 and greater was higher than the Overall rate in most states.

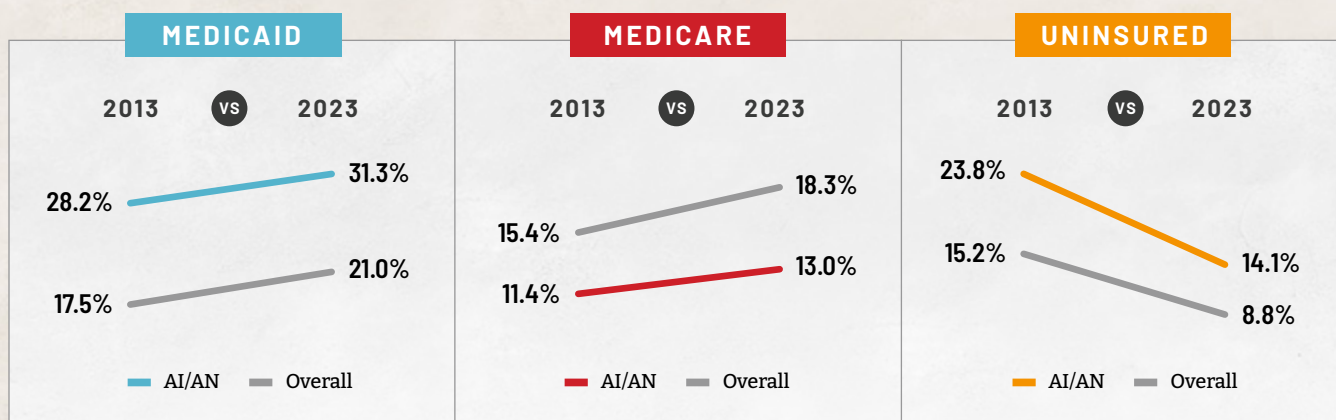

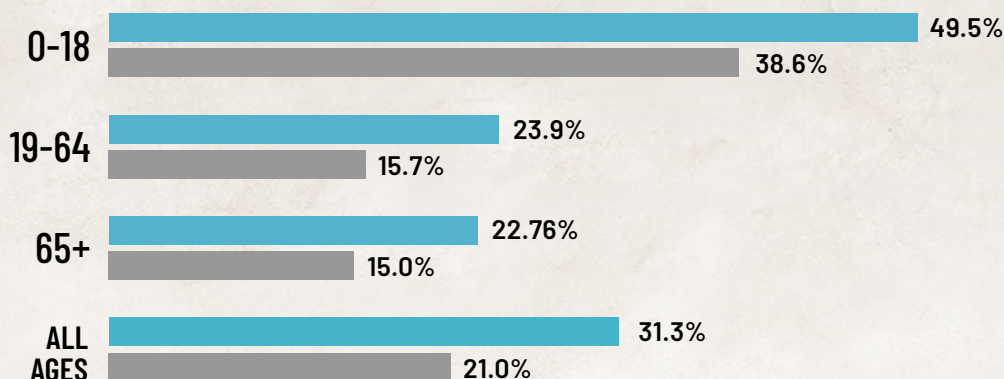

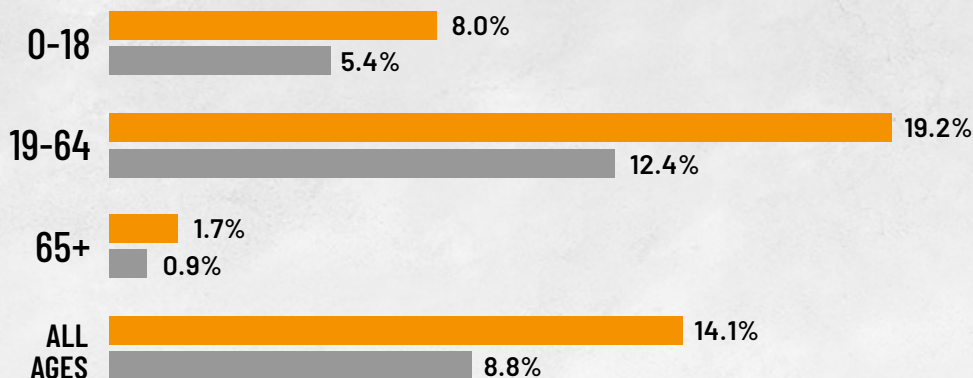
2023 AI/AN and Overall Population Medicaid Enrollment Rates by Age

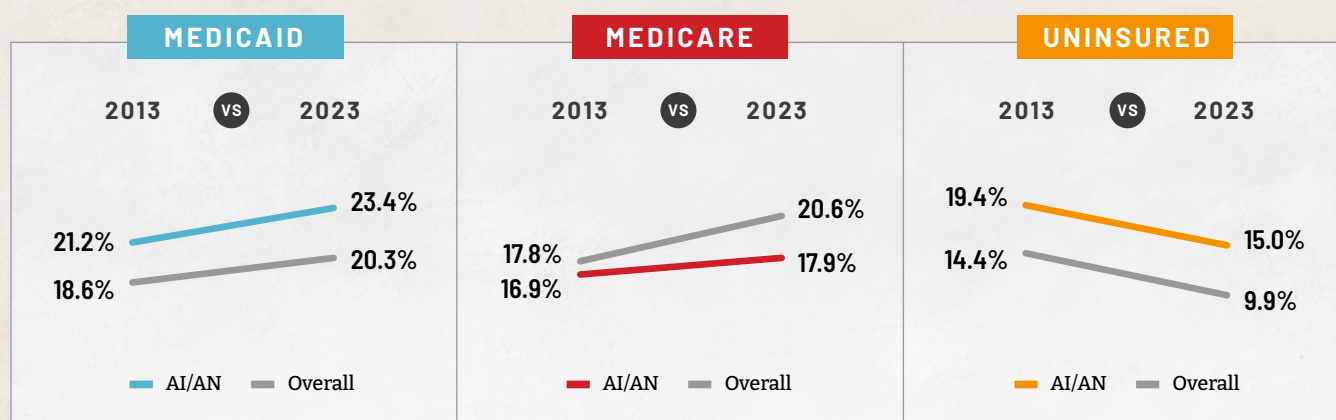

- ▶ **FOR AGES 65 AND GREATER**, the AI/AN dual enrollment rate is 7.7 percentage points higher than the Overall Population dual enrollment rate.
- ▶ **FOR AGES 0-18**, the AI/AN Medicaid enrollment rate is 10.9 percentage points higher than the Overall Population Medicaid enrollment rate.

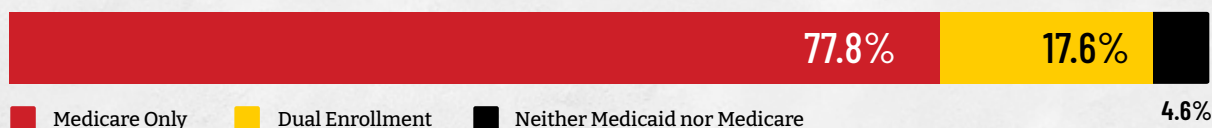

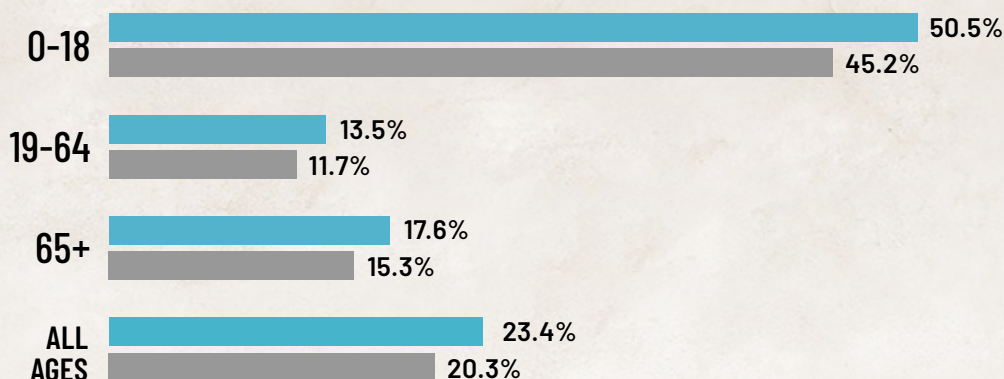

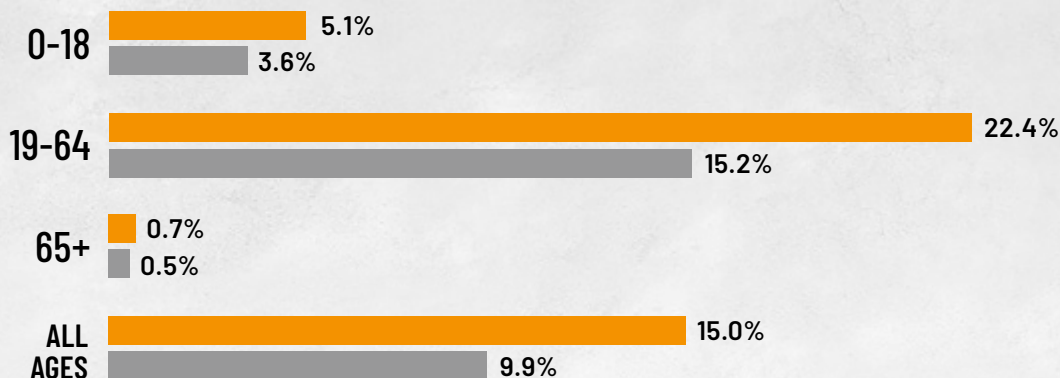
2023 AI/AN and Overall Population Medicaid Enrollment Rates by Age

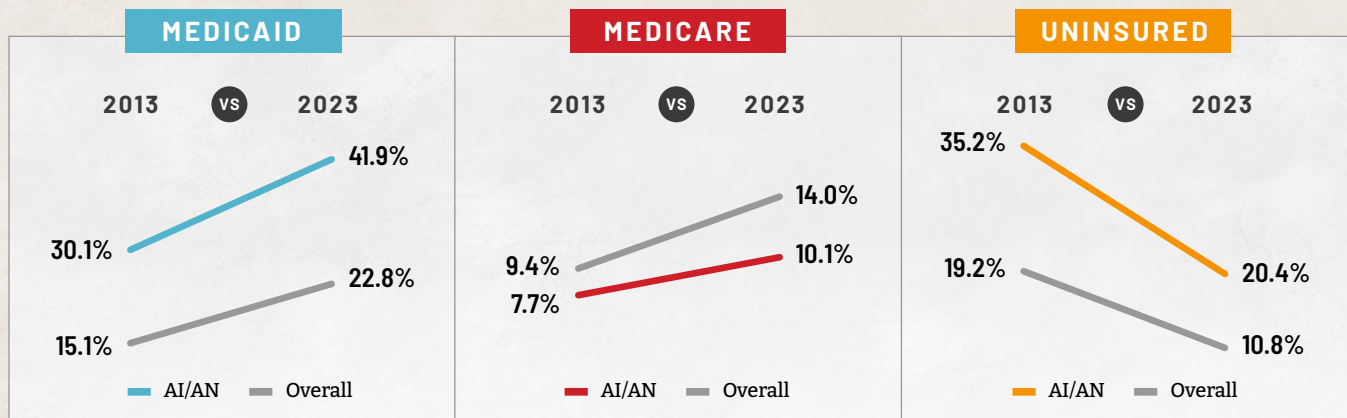

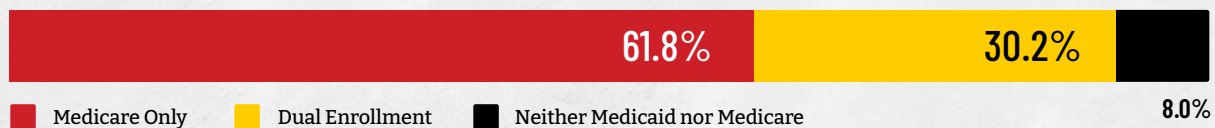

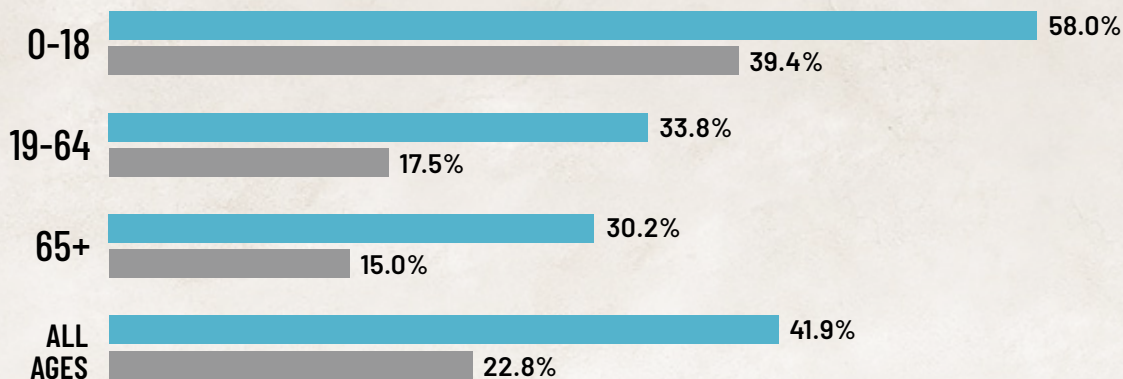

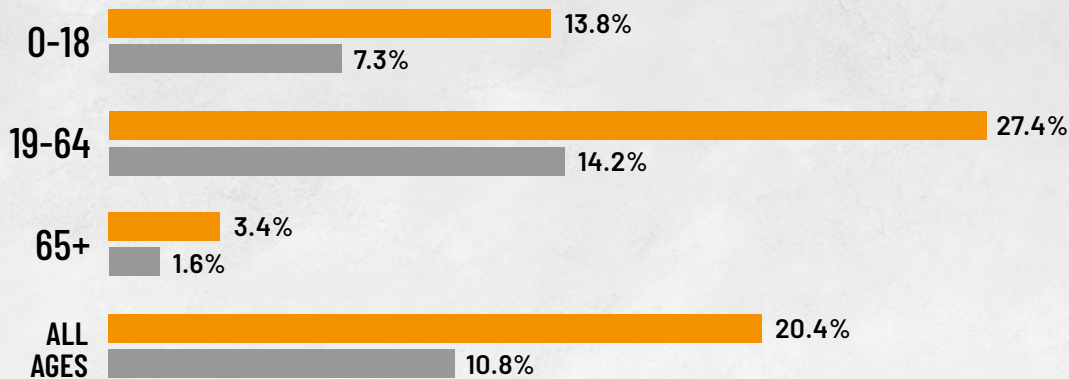
2023 AI/AN and Overall Population Medicaid Enrollment Rates by Age

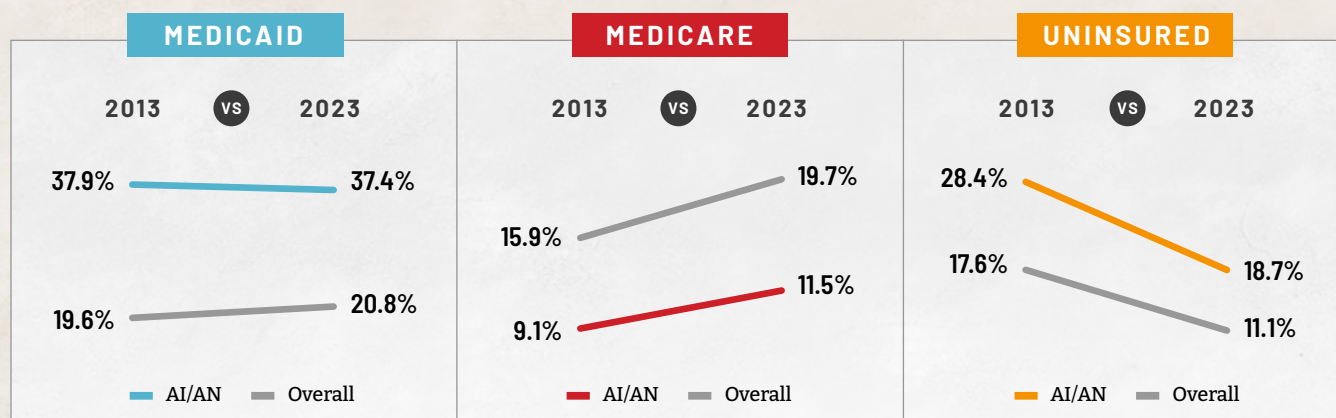

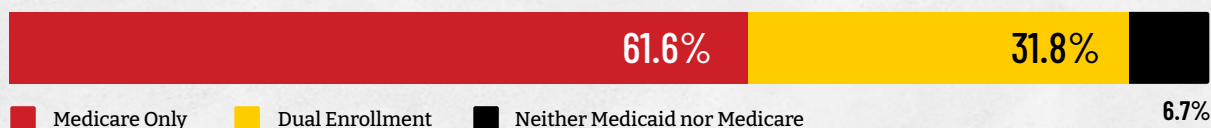

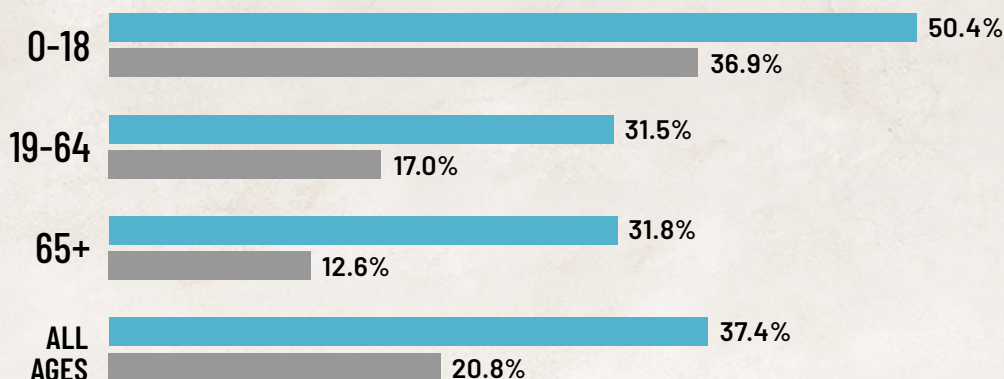

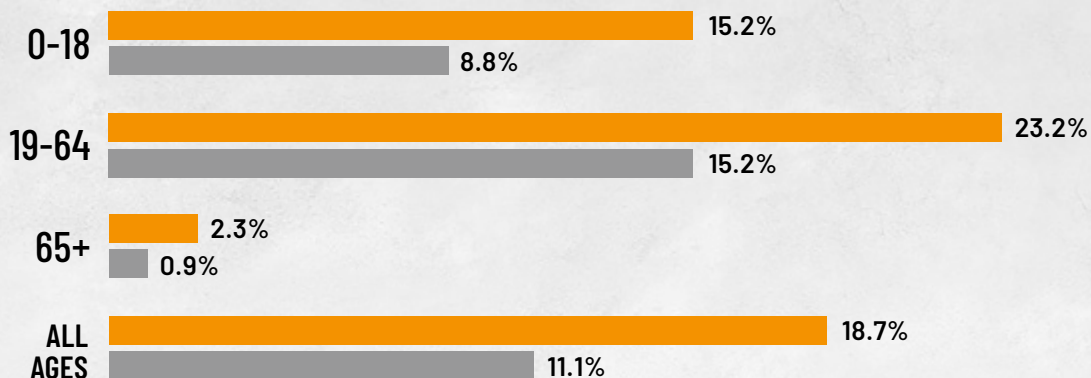
2023 AI/AN and Overall Population Medicaid Enrollment Rates by Age

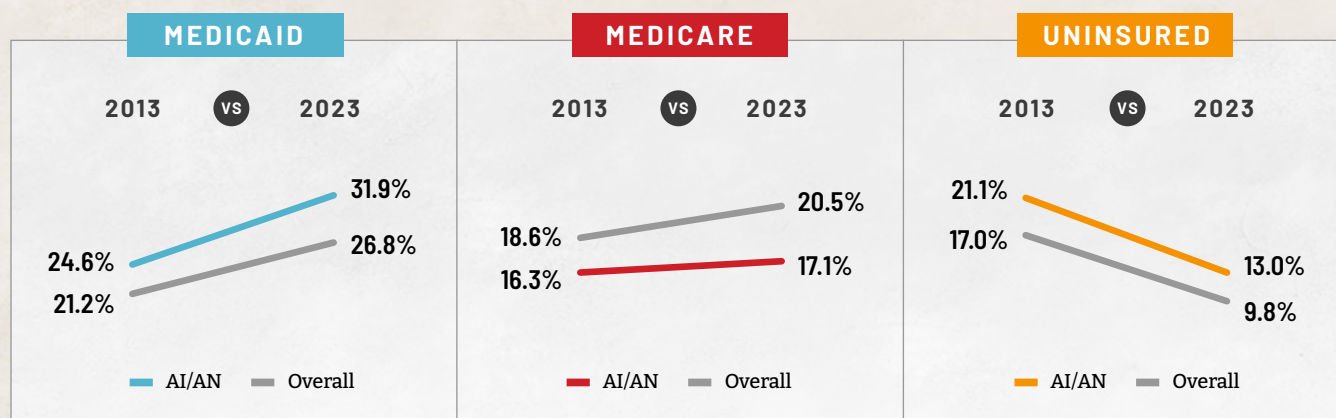

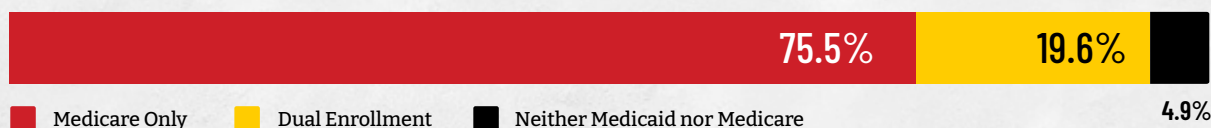

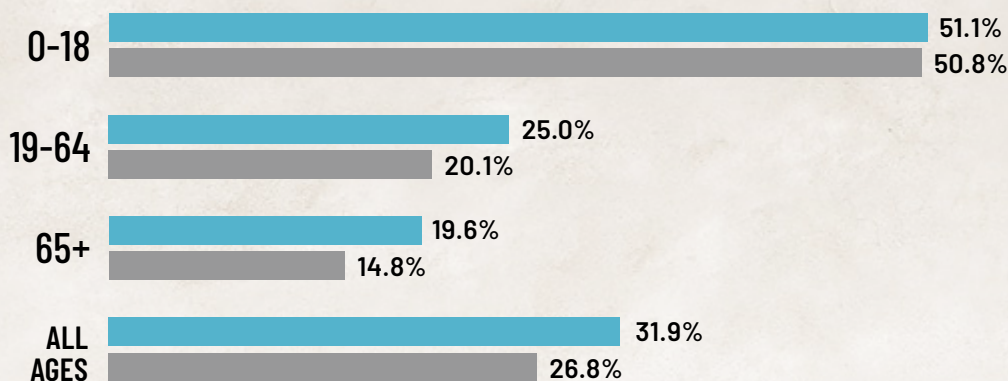

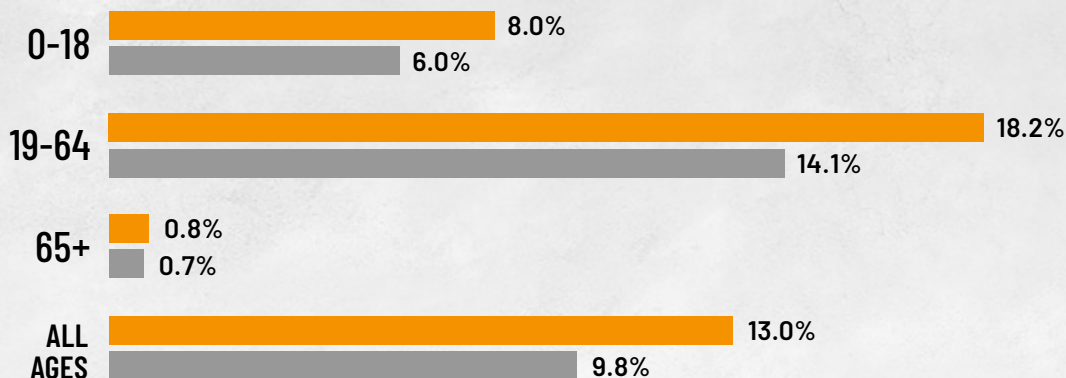
2023 AI/AN and Overall Population Medicaid Enrollment Rates by Age

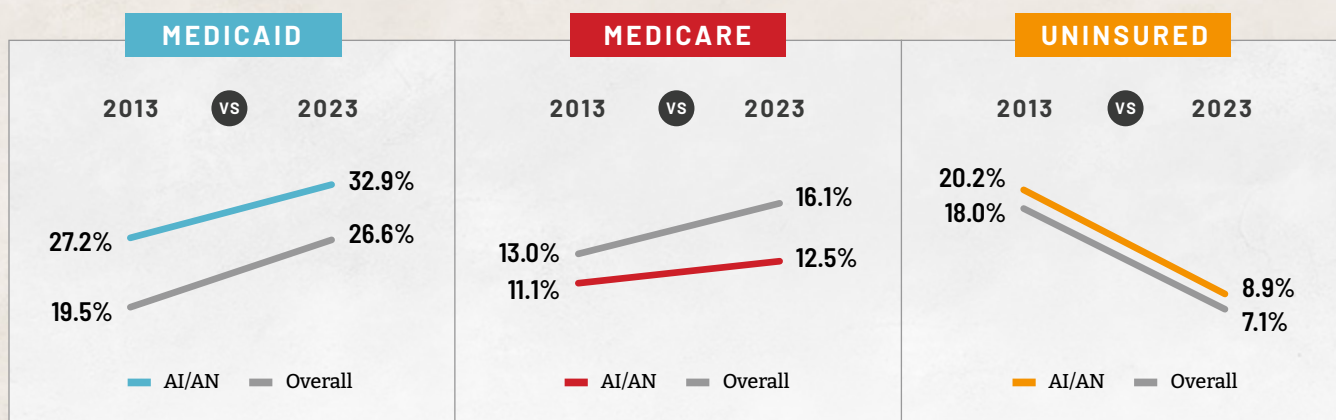

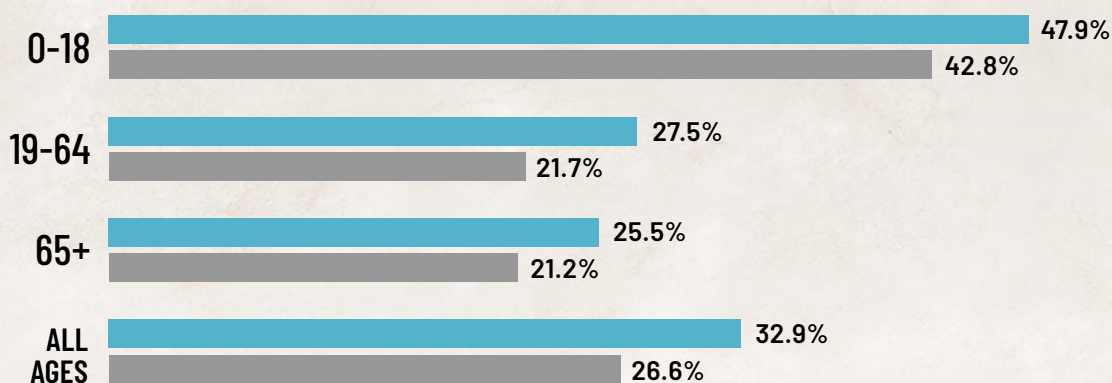

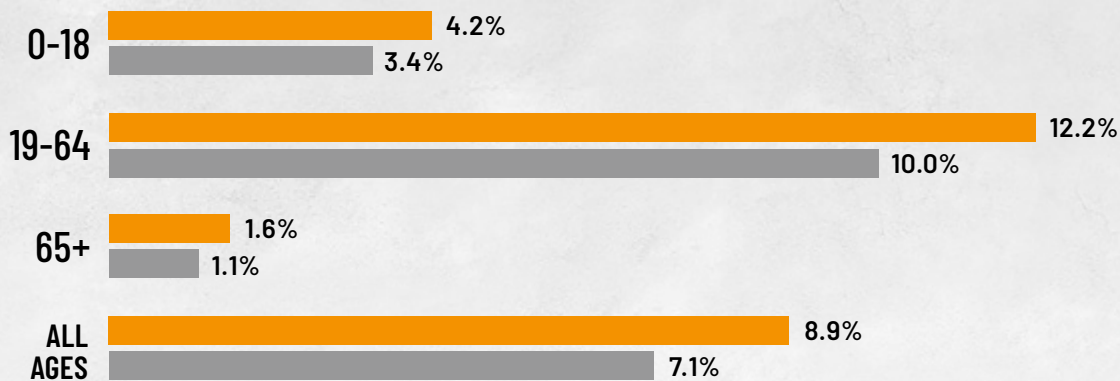
2023 AI/AN and Overall Population Medicaid Enrollment Rates by Age

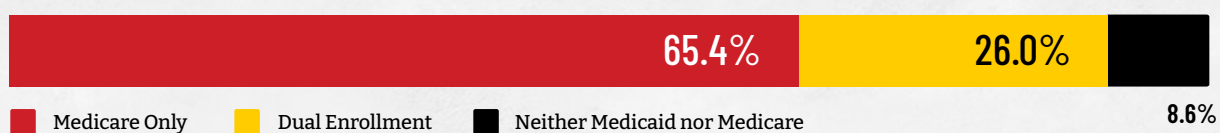

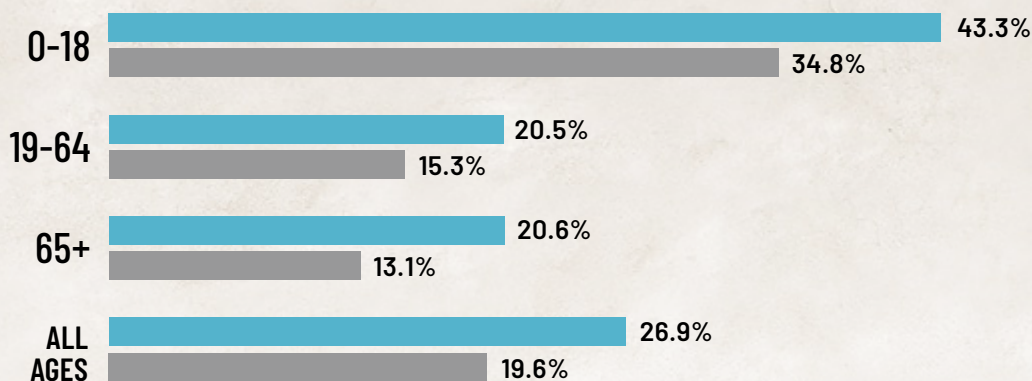

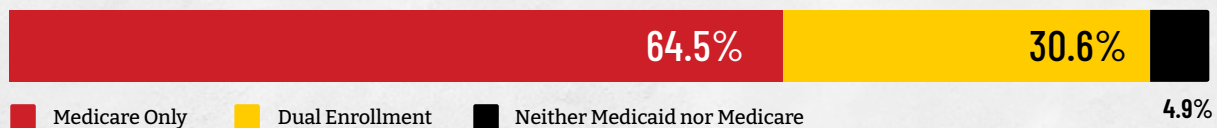

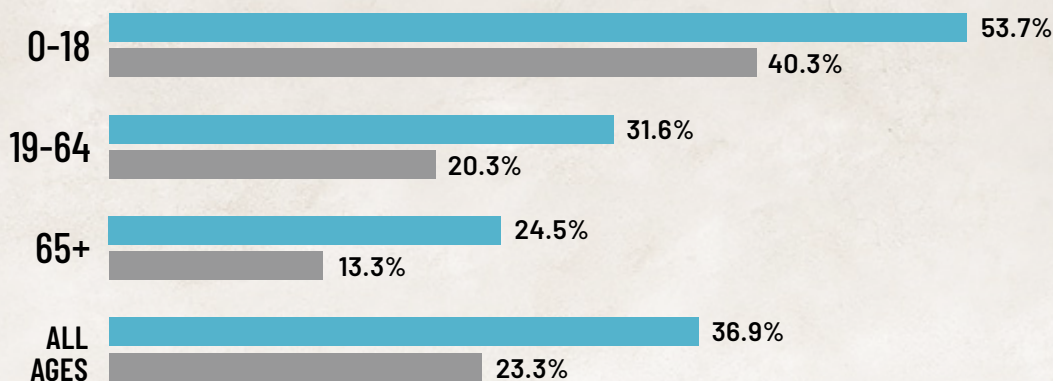

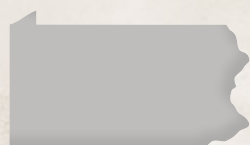

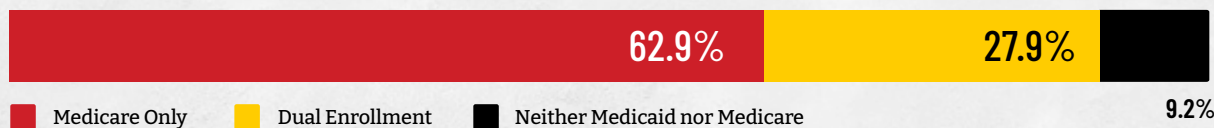
